Call to Order: Vice President Byers called the meeting to order at 6:00 p.m. with the Pledge of Allegiance.

Roll Call: Christopher G. Byers, Ginger L. Cinti, Thomas Eberle, Paul Orr, Joshua Sturgeon, Alan J. Watkins, and Mayor Andrew J. Graves were present. Stacy L. Lesnett was absent.

Appointed Officials Attending: Stacy L. Kibler/Borough Secretary.

Visitors Attending: Gregg Mitcho/Girard Borough Council, and Ron Rogers.

Tree Removal: Ginger Cinti motioned, and Paul Orr seconded, granting permission to Melissa Coulson of 10277 Rose Street to remove two trees within the curb lawn. All Agreed. Motion carried.

Minutes: Thomas Eberle motioned, and Joshua Sturgeon seconded, to approve the June 10, 2024, Minutes as presented. All agreed. Motion carried.

Bills for approval: Joshua Sturgeon motioned, and Thomas Eberle seconded, to approve the July bills, bill and payroll ratifications. All agreed, except Alan Watkins, who abstained because of a personal conflict. Motion carried.

West County Paramedics: is considering hiring an executive director to oversee the daily operations.

Sewer Plant Fence: Two quotes were received to repair the fence at the wastewater treatment plant: Erie Fence for \$8,327 and Keystone Fence for \$2,425. Thomas Eberle motioned, and Paul Orr seconded, to accept the quote from Keystone Fence. All agreed. Motion carried.

Paul Orr motioned, and Joshua Sturgeon seconded, to accept the quote from Keystone Fence to repair the fence behind the pavilion in the amount of \$600.00. All agreed. Motioned passed.

Tree Removal: PJ's Tree Maintenance quoted \$500.00 to remove the tree in Cherry Street Park and Memorial Park. Thomas Eberle motioned, and Ginger Cinti seconded, to accept the quote from PJ's Tree Maintenance. All Agreed. Motion carried.

Road Bond: Paul Orr motioned, and Joshua Sturgeon seconded, to require a \$3,000 road bond when making road cuts. All agreed, except Ginger Cinti and Alan Watkins. Motion passed.

Tire Recycling: Alan Watkins motioned, and Paul Orr seconded, to recycle eleven tires from the barn. All agreed, except Ginger Cinti. Motion carried.

Cameras: Joshua Sturgeon motioned, and Paul Orr seconded, to put camera access in the Borough Office. All agreed. Motion carried.
