Minutes: Thomas Eberle motioned, and Paul Orr seconded, to approve the ^{May 12,} ~~June 9,~~ 2025, minutes as presented. All agreed. Motion carried.

Bills for approval: Thomas Eberle motioned, Stacy Lesnett seconded, to approve the June bills and ratifications. Everyone agreed to the motion except for Alan Watkins, who abstained due to a personal conflict. The motion carried.

Water Transfer: Thomas Eberle motioned, Stacy Lesnett seconded, to approve the water transfer resolution. All agreed. Motion carried.

Cameras: Council postponed action on the camera quotes until the July meeting to ensure the quotes were comparable.

Salt Spreader: Alan Watkins motioned, Thomas Eberle seconded, to purchase a tailgate salt spreader from Forest Park for the F550. All agreed except Joshua Sturgeon.

Truck: Joshua Sturgeon motioned, Stacy Lesnett seconded, to have the electric and wing plow fixed on the International. All agreed except Alan Watkins and Thomas Eberle. Motion carried. Council requested the quotes for the new truck be updated to include a wing plow.

BIU Proposal: Joshua Sturgeon motioned, Thomas Eberle seconded, to accept the proposal from BIU for property maintenance inspections. All agreed. Motion carried.

Sleigh Resignation: Joshua Sturgeon motioned, Stacy Lesnett seconded, to accept the resignation of Brian Sleigh. All agreed. The motion carried.

Assistant Operator Position: Ginger Cinti motioned, Paul Orr seconded, to advertise the position for the assistant operator position.


Recess: President Byers recessed the meeting to an executive session at 6:47 p.m. for the non-uniform employees.
