Review and Discuss:

Properties within the distance for mandatory connection but do not connect to a sewer extension can be billed for reservation of capacity fees.

- 1. Preliminarily, the Lake City Borough will need to amend its ordinance, LCB Code Chapter 52, to include such a charge for a reservation of capacity fee.
- 2. The concept of billing for reservation of capacity is permitted pursuant to Pennsylvania Borough Code, 8 Pa. C.S.A. 2503. The billing of customers for reserve capacity is permitted in accordance with the billing for enumerated fees to property owners who are required to connect to an authority's sewer system. However, under the statute, the "...reservation of capacity fee or other similar charge may not exceed 60% of the average sanitary sewer bill for a residential customer in the same sewer service area for the same billing period." 53 Pa.C.S.A. 5607 (d) (24). The reservation of capacity charge is required to be "based on debt and fixed operating expenses."

Gary will work with LC Boro Atty Ed Betza on any revision. Adjourn: Darwin and Gerald.
