## Testing:

- \* Konzel with coordinate with Elk Creek ready Mix regarding superplasticizer.
- \* Konzel will keep as-built records and notes throughout construction and will submit a clean as-built set when the project is completed.
- \* The guiderails for pump 3 are corroded and may need replaced. Konzel will look into replacing the guiderails which would require bypassing the main lift station.

Potential upcoming changes in scope.

\* LCMSA and DHE are considering replacement of the grit drag out mechanism at the headwork's. DHE is working with the vendor of that equipment to develop a technical proposal. We will later discuss whether such work will be added to the scope of the Contract 2017-1. The Lake City Borough bids came in over \$40,000 over

budget. Motion by Rick and second by David to approve a change order to Konzel project 2017-1 based upon the approval by DEP and PennVest. Final cost at the next.
