## April 12, 2021

**Call to Order**: President Gollmer called the meeting to order at 7:00 p.m. with the Pledge of Allegiance.

**Roll Call:** Christopher Byers, Ginger Cinti, Thomas Eberle, Raymond H. Fisher, Mary G. Gollmer, Jenny L. Potter, Bettie Stephens and Mayor Andrew J. Graves were present.

Appointed Officials Attending: Edward J. Betza /Solicitor, and Stacy L. Kibler/Borough Secretary,

Visitors Attending: Gregg Mitcho and Robin Roberts.

Tammy Hetz, of 10155 Loomis Lane, would like Council to repair her driveway after the plow damaged the apron. Council tabled the issue until a concrete contractor could look at the driveway.

Kathy Moiser, of 10380 Clifton Drive, requested an adjustment on her sewer bill after finding a water leak under concrete slab foundation. After a brief discussion, Thomas Eberle motioned, Raymond Fisher seconded, to adjust Kathy Moiser sewer bill \$114.75, upon proof that a leak had been fixed. All voted no, except Thomas Eberle, Raymond Fisher and Mary Gollmer. Motion failed.

James LeRoy, of 2367 Main Street, requested permission to remove five dying trees within the curb lawn. Ginger Cinti motioned, Christopher Byers seconded, to permit James Leroy to remove the five trees. All agreed. Motion carried.

**Minutes:** Christopher Byers motioned, Thomas Eberle seconded, to accept the March 8, 2021, Minutes, as presented. Motion carried. All agreed.

**Bills for Approval:** Christopher Byers motioned, Thomas Eberle seconded, to approve the April Bills for approval. All agreed. Motion carried.

Christopher Byers motioned, Bettie Stephens seconded, to ratify the April Out of Sequence Bill Payments. All agreed. Motion carried.

**Body Cameras:** Christopher Byers motioned, Thomas Eberle seconded, to purchase nine body cameras, with docking stations, from North East Borough, at an expense of \$1,000. Council and Police Department will develop, and agree upon a body camera policy, before the cameras are instated. All agreed. Motion carried.

Paving Project: The following three quotes were received for 2021 paving project:

Christopher Byers motioned, Ginger Cinti seconded, to accept the bid proposal from Cross Paving. All agreed, except Thomas Eberle, who abstained because of relative conflict. Motion carried. The streets to be milled and paved are: the entire lengths of Northpark Drive, Hall Avenue and Seeley Street. Main Street will be paved from State Route 18 to Sampson Avenue.

**Street Sweeping:** Lindy Paving submitted a quote of \$230.00 an hour to sweep the streets. Admar quoted \$1,685.00 for a week rental of a skid steer with sweep attachment. Christopher Byers motioned, Thomas Eberle seconded, to accept the Admar rental quote. All agreed. Motion carried. Council requested the Secretary make sure the broom attached was not at an angle, and it swept into the bucket. The Borough Crew will document their time when sweeping.

**Nuisance Ordinance:** Thomas Eberle motioned, Bettie Stephens seconded, to accept the amendment to the Nuisance Ordinance. All agreed, except Ginger Cinti and Mary Gollmer. Motion carried. The amendment will allow commercial properties to store vehicles for forty-five days.

**Edgepark Liftstation:** Ginger Cinti motioned, Christopher Byers seconded, to install an emergency pump hook-up at the Edgepark Drive Lift Station, which is not to exceed \$8,000. If the quote is over the estimated price, Council will revisit the issue. All agreed. Motion carried.

**Mayor Conference:** Raymond Fisher motioned, Thomas Eberle seconded, to approve the lodging and conference expenses for the Mayor to attend the Annual Mayors Conference in Pittsburgh. The Mayor must provide a detailed report at the Council Meeting, immediately following the conference. All agreed, except Ginger Cinti. Motion carried.

**Barn:** Council tabled discussing the repairs at the barn and sewer plant, until additional quotes could be obtained.

**Laughlin Subdivision:** Robin Roberts, 2954 Mechanic Street, appeared to get an update on the water line. Council informed Ms. Roberts they were still awaiting a response from the Department of Environmental Protection.

**Adjourned:** President Gollmer recessed the meeting at 8:22 p.m. President Gollmer reconvened and immediately adjourned the meeting at 8:57 p.m.
